### Course Overview:

United States History II is designed as a survey course, beginning with the Emergence of Modern America and continuing to current times. This course provides students with a framework for studying political, social, economic and cultural issues and for analyzing the impact these issues have had on American society. As an honors course, students should expect a rigorous content level and pace. This course demands greater independence and responsibility and concentrates on the development of higher level thinking skills.

# Course Objectives:

#### **Chronological Thinking:**

- To compare present and past events to evaluate the consequences of past decisions and apply lessons learned.
- Analyze how change occurs through time due to shifting values and beliefs as well as technological advancements and changes in the political and economic landscape.

#### **Spatial Thinking:**

- Construct various forms of geographic representations to show the spatial patterns of physical and human phenomena.
- Relate current events to the physical and human characteristics of places and regions.

#### **Critical Thinking:**

- Distinguish valid arguments from false arguments when interpreting current and historical events.
- Evaluate sources for validity and credibility and to detect propaganda, censorship, and bias.

#### **Presentational Skills:**

 Take a position on a current public policy issue and support it with historical evidence, reasoning, and constitutional analysis in a written and/or oral format.

## Organization of Course:

Honors United States History II will meet every other day for a 90 minute session. These sessions are held in room 126 of the high school, unless otherwise noted.

This course is structured around four main activities: (1) discussion of key terms and concepts, (2) examination of primary sources, (3) analysis of essential questions, and (4) practice of written expression via Short Constructed Responses (SCR) and Document Based Questions (DBQ).

All assigned readings will be completed outside of class before they are discussed in class, unless otherwise noted by the instructor. This will most likely require that students spend time each week reading and taking their own notes on assigned materials.

Exams will include multiple-choice questions followed by DBQs. Remediation will be offered for each unit exam during SAP.

Each student will be required to bring a 1-subject or marble notebook to every class session.

Random notebook checks will happen regularly throughout the marking period to ensure students keep up with the work and keep an organized record of their learning.

ALL RELEVANT INFORMATION RELATED TO THE COURSE WILL BE POSTED ON GOOGLE CLASSROOM OR COMMUNICATED VIA REMIND. (Students will receive these codes in class on the first day of school).
